El suscrito Secretario General de la Gobernación de Bolívar, en uso de sus facultades Delegadas,

CONSIDERANDO

1- Que mediante decreto 379 de 26 de mayo de 2016 el Gobernador del Departamento de Bolívar delego en el Secretario de Despacho Código 020 Grado 04, asignado a la Secretaria General, la facultad de expedir la resolución motivada y la ordenación del gasto para el reconocimiento y pago a las IPS prestadoras de servicios, por aquellas atenciones a la población pobre y vulnerable no asegurada o de ordenamientos NO POS, que en virtud de la ley 715 de 2001 y la Ley 100/93, conforme a la reglamentación correspondiente, son responsabilidad del Departamento.

2- Que por decreto 348 del 13 de Mayo de 2016 del Señor Gobernador del Departamento de Bolívar, el Dr. JOHANN DE JESUS TONCEL OCHOA, identificado con la cedula de ciudadanía No. 7.140.174 fue nombrado de manera ordinaria en el cargo de Secretario de Despacho, Código 20 Grado 4, asignándolo a la Secretaria General del Departamento de Bolívar, cargo en el que se encuentra debidamente posesionado.

3-Que el artículo 49 de Constitución política de Colombia, modificado por el Artículo 1º del acto legislativo 2 de 2009, establece:

“La atención de la salud y el saneamiento ambiental son servicios públicos a cargo del estado. Se garantiza a todas las personas el acceso a los servicios de promoción, protección y recuperación de la salud”.

Corresponde al Estado organizar, dirigir, y reglamentar la prestación de servicios de salud a los habitantes y de saneamiento ambiental conforme a los principios de eficiencia, universalidad y solidaridad. También establecer las políticas para la prestación de servicios de salud por entidades privadas, y ejercer su vigilancia y control. Así mismo, establecer las competencias de la Nación, las entidades territoriales y los particulares y determinar los aportes a su cargo en los términos y condiciones señalados en la ley.

Los servicios de salud se organizaran en forma descentralizada, por niveles de atención y con participación de la comunidad.

La ley señalara los términos en los cuales la atención básica para todos los habitantes será gratuita y obligatoria”.

4- Que conforme al Artículo 8º de la Ley Estatuaria de la Salud, que desarrolla el principio de integralidad para la prestación de los servicios de salud, estos y las tecnologías de salud deberán ser suministrados de manera completa para prevenir, paliar o curar la enfermedad, con independencia del origen de la enfermedad o condición de salud, del sistema de provisión, cubrimiento o financiación definido por el legislador.

Advierte dicha norma que con ocasión de lo anterior, no podrá fragmentarse la responsabilidad en la prestación de un servicio de salud específico, en desmedro de la salud del usuario, frente a ella explica:

“En los casos en los que exista duda sobre el alcance de un servicio o tecnología de salud cubierto por el Estado, se entenderá que este comprende todos los elementos esenciales para lograr su objetivo médico respecto de la necesidad específica de salud diagnosticada”

5- Que la Ley 100/93, la Seguridad Social Integral es el conjunto de instituciones, normas y procedimientos, de que dispone la persona y la comunidad para gozar de una calidad de vida, mediante el cumplimiento progresivo de los planes y programas que el Estado y la sociedad desarrollen para proporcionar la cobertura integral de las contingencias, especialmente las que menoscaban la salud y la capacidad económica, de los habitantes del territorio nacional, con el fin de lograr el bienestar individual y la integración de la comunidad.

6- Que dentro de las competencias de las entidades territoriales en el sector salud, la misma ley 715 en su artículo 43.2 determina lo siguiente: “43.2. De prestación de servicios de salud 43.2.1. Gestionar la prestación de los servicios de salud, de manera oportuna, eficiente y con calidad a la población pobre en lo no cubierto con subsidios a la demanda, que resida en su jurisdicción, mediante instituciones prestadoras de servicios de salud públicas o privadas. 43.2.2. Financiar con los recursos propios, si lo considera pertinente, con los recursos asignados por concepto de participaciones y demás recursos cedidos, la prestación de servicios de salud a la población pobre en lo no cubierto con subsidios a la Demanda y los servicios de salud mental.”

7- Que la Resolución 5521/13, que definía hasta el 31 diciembre de 2015, la cobertura del Plan Obligatorio de Salud ordenaba:

ARTICULO 9. GARANTIA DE ACCESO A LOS SERVICIOS DE SALUD. Las Entidades Promotoras de Salud deberán garantizar a los afiliados al SGSSS el acceso efectivo a las tecnologías en salud incluidas en el presente acto administrativo, a través de su red de prestadores de salud.

En caso de atención inicial de Urgencias, las Entidades Promotoras de Salud deberán garantizarla también por fuera de su red, de acuerdo con lo dispuesto en artículo 25 de este acto administrativo.

En punto de lo cual, a contrario sensu, igual procedimiento se aplica a los no afiliados al SGSSS, que conforme a la Ley 715/01, son de responsabilidad del Departamento de Bolívar, que son atendidos con cargo al subsidio a la demanda.

8- Que conforme al artículo 3 de la Resolución 5395/13, aplicable para el caso concreto, debe entenderse por recobro, la solicitud presentada por una entidad recobrante, a fin de obtener el pago de cuentas por concepto de tecnologías en salud no incluidas en el Plan Obligatorio de Salud (POS), cuyo suministro fue

9- Que conforme a la normatividad vigente, se entiende por tecnologías en salud todas las actividades, intervenciones, insumos, medicamentos, dispositivos, servicios y procedimientos usados en la prestación de servicios de salud, así como los sistemas organizativos y de soporte con los que se presta esta atención en salud, cuyos valores se reconocen bajo el sistema de "Comparador administrativo", para definir el monto a recobrar por aquella tecnología en salud que es objeto de recobro.

10- Que sólo procede, el reconocimiento y pago de las facturas presentadas, una vez se cumpla con el cierre efectivo del proceso de verificación, agotando las etapas de prerradicación, radicación, preauditoría y auditoría integral del proceso de cobros adelantado por la Secretaría de Salud del Departamento

11- Que la auditoría integral, según el Manual Único de Glosas, adoptado por la Secretaría de Salud del Departamento de Bolívar, corresponde a la etapa del proceso en donde se revisan las solicitudes presentadas por las entidades recobrantes, considerando tres aspectos a saber: técnico-médico, jurídico y financiero; los cuales se analizan de forma conjunta y completa, con el fin de obtener un resultado que da lugar al reconocimiento y pago de las tecnologías en salud NO POS. Por el contrario, el incumplimiento en alguno de los requisitos previstos, da como resultado la aplicación de una glosa.

12- Que los valores a pagar, hacen parte de la auditoría integral, bajo la aplicación del sistema de comparador de precios, prescrito en el artículo 12 de la Resolución 1479/15, según sea la tarifa vigente al momento de la prestación del servicio.

13- Que en razón de que existen situaciones administrativas especiales que requieren la necesidad de realizar los pagos de las atenciones realizadas por los diferentes prestadores de servicios en el marco de la demanda de los usuarios que en virtud de la Ley 715 de 2001 son responsabilidad del Departamento, correspondiendo para el presente evento la afectación del rubro presupuestal RECOBROS DE LAS EPS DEL REGIMEN SUBSIDIADO POR EVENTOS NO INCLUIDOS EN EL POS – PRESTACION DE SERVICIOS DE SALUD A LA POBLACION POBRE AFILIADA AL REGIMEN SUBSIDIADO NO INCLUIDOS EN EL PLAN OBLIGATORIO DE SALUD (POS) de conformidad con el **Certificado de Disponibilidad Presupuestal No.2093 de Fecha 22/12/16.**


